

RIPOTI A LE TAITAIFONO



I le agaga faagaeetia e tuuina atu ai lenei ripoti e tusa ai ma laasaga maualuga sa ausia e le Faalapotopotoga o Fale faapea ai ma ana matatia autu ua o gatasai ai ma le faatumutumuga o manaoga ina ia siitia le soifua lelei o tagatanuu o Samoa. O le faaleleiga o siosiomaga o fale mo le lautele o le atunu e moomia tele le galulue faatasi e auala i le tuuina atu o fesoasoani talafeagai mo manaoga o le atunu i se tulaga autasi. E le'i malolo le Faalapotopotoga i taumafaiga ina ia faamalieina talosaga mo nonogatupe o fale faapea foi i ana fale mautotogi.

O lenei tausaga faaletupe ua maitauina le toe siitia lea o tupe faasili a le Faalapotopotoga i le 9%, e faapea foi i ana meatotino faavae i le 4%, ao faapea ona siitia foi ana tupe faaleoleo i le 4% e faatusatusa i le tausaga 2017. Mo fale mautotogi, e tusa ma le 95% ua maea faaleleia mo le tuuina atu i le mamalu ole atunu. Ole 5% o fale o lo o faapea ona faia galuega faaleleia i le tausaga fou.

I lalo o vaega o nonogatupe, e tusa ma le 56% o fale o lo o fausia i luga o fanua faaleaganuu. O se faatosina lelei mo o tatou tagata e nonofo ma atinae o latou aiga i nuu ma afioaga. O lo o iai pea le faamoemoe o le Malo ina ia toe faaolaola fale mautotogi ma tuuina atu i ni tau talafeagai mo le mamalu o le atunu.

O soo se nonogatupe e faamatuu e sua lava i le malosiaga tau tupe e totogi ai se aitalafu. O lea tulaga ua faia ina ia mautinoa le tumau pea ona mausali tupe maua aemaise le faaaauauina o le auaunaga a le Faalapotopotoga. E ui ina tele luitau i le tamaoaiga o le atunu ma le lalolagi, peitai o lo o maitauina le mafai ona maua tupe faasili a le Faalapotopotoga i ia siosiomaga faatauva. Peitai e le mafai e ia vaega ona taofia le faaaauau pea o nonogatupe mo e lima vaivai ona o le matafaioi autu na faatu ai e le Malo le Faalapotopotoga ma faasino mai ona tiute fai.

O le faatinoina o galuega i tulaga mamalu ma aloaia e aunoa ma ni fa'aalatua, e tausisia tele e le Faalapotoptoga ina ia malu puipuia lona tamaoaiga aemaise le maitau mai a le Malo ma le atunu, faapea le usitaia o tulafono i pulega lelei ma manino. O lo o faaaauau pea ona faa'oloaina sui ole Komiti Faatonu i ia agavaa ina ia tu maualuga pea ia vaaiga i le faafoeina o le Faalapotopotoga. E toalima sui ole Komiti Faatonu ma o se faatusaga i le 80/20 i le sui alii ma tamaitai. E 12 fono sa faatinoina e le Komiti i lenei tausaga e aofia ai ma le 6 o fonotaga sa faia e Soakomiti e mata'ituina vaega ma'aleale, faapea le Soakomiti mo fale mautotogi.

O faigapaaga ma le Faalapotopotoga o Faletupe a le Pasefika faapea Asia, (ADFIP & ADFIAP) o lo o maualuga pea, ua atili unaia ai le vave ausia o ana fuafuaga mamao.

E avea lenei avanoa e fai ai a'u ma sui o le Komiti Faatonu, e faafetai atu ai i le Minisita, Malo, Pule Sili, Pulega faapea le aufaigaluega mo lenei foi tausaga ua faaiuina ma le manuia.

CHAIRMAN'S REPORT

I am pleased to report the significant growth of the Corporation in this financial year as it strategically achieved its goals that corresponded to the national theme of improving the welfare of the Samoan people. Enhancement of the living standards of the general public requires holistic approach with the provision of adequate housing necessities. The Corporation relentlessly accommodated the continuous demand for affordable housing for both its lending and rental functions.

The financial performance for this year reflected once again the improvement in profitability by 9% and asset base by 4% while capital and reserves also increased by 4% compared to 2017. From the total rental housing stock administered by the Corporation, 95% has been renovated with the remaining 5% to be completed in the next financial year with a 90% occupancy rate and improving continuously.

Some 56% of the lending portfolio represents housing projects on customary lands. This provides the incentives for people to live and undertake developments in their village communities. Government continues to support the work of the Corporation on its efforts in reviving its rental property investment as well as providing affordable rental rates and housing finance.

Financial assistance depends largely on one's capacity to repay. As for this assurance, the Corporation's business is viable. Furthermore, it is immensely encouraging to note the Corporation is persistently profitable under prevailing severe economic climate. Although the risk of lending to the most vulnerable sector of the community is quite high, its mandated social interest is crucial in pursuing for compliance.

Good governance and accountability is embraced and practiced in the corporate level through trainings in pursuing a successful and sustainable business. The Corporation's Directors are well equipped with such values for the betterment of the Corporation. Ongoing trainings through the Samoa Institute of Directors professional development programme to upskill Directors is paramount for good governance. There are five Directors on the Board with a male to female ratio of 80/20. A total of 12 meetings of the Board were held in this financial year with a total of 6 meetings of the Audit and Rental Sub-Committees.

Affiliation with the prestigious international development financing associations namely ADFIAP (Association of Development Financing Institutions of Asia Pacific) and ADFIP (Association of Development Financing Institutions of the Pacific) further propels the Corporation to sustainable success.

On behalf of the Board of Directors, I congratulate the Minister and Government, CEO, Management and staff for another successful year for the Corporation.

RIPOTI A LE OFISA SILI



O lenei tausaga e manatu ua faamalieina e le Faalapotopotoga ona nafa tauave e tusa ma ona laasaga moomia i fale gafatia o latou tau, faapea foi i fale mautotogi. O se auaunaga taua ma faamalieloto mo le mamalu o le atunuua ona o le toatele o ē sa le maua ni avanoa i faletupe tumaoti lea ua agavaa i nonogatupe mai le Faalapotopotoga.

E fia faailoa nisi o matatia ausia ona o le faatinoga lelei o galuega tauave a le Faalapotopotoga. I lenei tausaga e 6% na siitia ai le aofaiga o nonogatupe a le Faalapotopotoga e tusa lea ma le \$48.5 miliona tala mai le tausaga ua tuanai, ma o se siitaga e atagia ai le moomia tele o lenei auaunaga mai le mamalu o le atunuuu. E aofia i lenei siitaga le naunautaiga ina ia faaleleia paaga a le Faalapotopotoga i ona tulaga uma, ina aua nei aafia ana tupe maua aemaise aitalafu e vaivai meatotino o puipuia ai. E \$22,204,308 le siitaga o nonogatupe sa taliaina e tusa lea ma le 5% ua maualuga ai ma le tausaga ua tuanai, pe tusa lea ma le \$1.9 miliona tala nonogatupe sa taliaina i le masina.

I le tele o luitau ona uiga faatauvaga i nonogatupe o fale, peitai sa tu maualuga pea le gafatia o tupe maua faapea ana auaunaga masani. E faailoa lea i tupe faasili e \$1.2 miliona tala poo le 9% ua siitia ai ma le tausaga ua tuanai. O tupe maua mai i le sao o le Malo, e 3.7% sa faapea ona maua ua talafeagai ma auaunaga e tuumama ai aiaiga faaunetupe. O ni faaiuga ua mautinoa ai le taumafai i tupe toe ao mai faapea le tuuitiitia o tau mo tatou tagata.

I le itu o fale mautotogi, o le faaleleia o ia fale ina ia ausia le siosiomamaga lelei mo e faaaogaina, sa tuu iai le faamamafa ina ia talatutusa ma isi ituaiga o fale faapea i le maketi. O tupe sa faaaluina mo ia galuega e tusa lea ma le \$695,535 ma o lo'o faapea ona faagaoioi lea vaega i se tualaga maualuga e tusa ma faiga faavae e patino i lea matafai.

I lenei foi tausaga, sa faaaogaina ai le auaunaga ofoina sua ise faiga faapaaga ma le Malo o Ausetalia i tomai faapitoa ina ia iloiloina galuega faatino a le Faalapotopotoga, ma sa faapea ona faaopopo nisi auala faapulega ina ia faaleleia atili ana auaunaga. I sootaga ma Faalapotopotoga Tutoatasi, pei o le Sosaiete o le Kanesa, Maota mo e matutua i Mapuifagalele, sa oo iai le fesoasoani ina ia tumau pea fesootaiga ma o tatou tagata lima vaivai ma e gasegase. E aofia foi i ia galuega, fale nofo e auala i nonogatupe silisili ona maualalo tului i se auala faapaaga ma le ADRA & HABITAT. E 290 fale sa fausia e tusa lona tau aofai ma le \$2.7 miliona tala, ma sa faapea ona amanaia lea auaunaga i ni faailoga taualoa mai le Faalapotopotoga o Faletupe Atina'e i le Pasefika ma Asia (ADFIAP).

O ia uma auaunaga maualuga, o atagia ai taumafaiga e faaleleia le tomai i galuega mo le aufaigaluega, e ala i aoaoga faavaitaimi i atunuua mamao faapea Samoa nei. Ina ia faaoloaina le aufaigaluega i tomai lelei ma aoga ia maualuga pea le faatinoina o galuega i aso faisoo.

E avatu le faamalo i le Komiti Faatonu, Pulega, faapea le aufaigaluega ma ana paaga masani, e faafetaia ai le auaunaga faamalieloto lea ua tau i manū le faafitiga ma ua a'e manuia foi faiva aua lava Samoa ma ona tagatanuu ina ia manuia.

CHIEF EXECUTIVE OFFICER'S REPORT

The financial year 2018 has been successful and challenging as the Corporation persistently pursued its strategic direction in its mission of being the dynamic leader in financing affordable homes and rental properties. This vital role in providing reasonable financial assistance has enabled accessibility of people not usually eligible for loans in commercial banks and remarkably served the legislated social interest of the Corporation.

Significant results reached this year were the outcome of prudential management. The growth of the portfolio to \$48.4 million reflected a rise of 6% from FY 2017. This is the effect of the enormous demand for loans from the general public. Determination to level up the quality of the portfolio pressed the increased approval of mortgaged loans that countered the inherited risk of the unsecured portfolio. Loans approval totalling to \$22,204,308 recorded an increase of 5% from the previous financial year indicating an average monthly approval of \$1.9 million tala.

Notwithstanding the challenges such as rigorous competition in the housing market, high costs of goods and services and pursuit of delinquent accounts, profitability and efficiency prevailed. The Net Profit of \$1.2 million noted a rise of 9%. Return on Equity(ROE) correspondingly increased to 3.7%. Such results indicated the effort on maximizing sales and collections as well as reducing costs wherever possible.

Upgrading of the housing rental stock is a continuous challenge in keeping abreast with the market standards and sustainability assurance. The rental property operation is progressing well despite the constraints of limited resources and unforeseen uncontrollable circumstances. Total capital costs in upgrading the housing stock this year amounted to \$695,535.

The Corporation was also able to employ a consultant through the Samoan Governance Support Programme to review the operation of the Corporation to optimise its performance. The programme was successfully completed with constructive measures to further improve the operation in the way forward. Involvement of the Corporation in Non Government Organisation (NGO) activities such as the Cancer Society, the Mapufagalele Elderly Home and other community services was paramount in terms of serving its social interest. The HAS (Habitat for Humanity (NZ), ADRA, and SHC Project concluded its three year program towards the end of 2018 as scheduled building 290 affordable houses on concessionary terms with a total disbursed value of \$2.7 million tala. The Corporation was recognised through achievement awards from the international renowned Association of Development Financing Institutions for Asia and Pacific (ADFIAP) for its social inclusion Project H.A.S.

The exceptional results on the operation this year is highly noted as a reflection of ongoing staff capacity building on risk assessment, management capability, operational efficiency and recovery work. The employees are well equipped with the appropriate skills that enable proper execution of assigned duties.

I wish to thank the Chairman, Board of Directors, Management, staff and all stakeholders for their commitment dedication and support enabling a successful and fruitful year for the Corporation and the people of Samoa.



NOTES TO FINANCIAL STATEMENTS
FOR THE YEAR ENDED 30 JUNE 2018

1. General Information

The Housing Corporation was established on May 1990 by an act of the legislature (Housing Corporation of Samoa Act 1989). The new legislation, Public Bodies (Performance and Accountability) Act 2001 overrules the initial Act. However, review of the Housing Corporation Act 1989 was approved by Parliament in 2010 as Housing Corporation's Act 2010 and is now enacted. The main purpose of the Corporation is to improve housing and living conditions of lower moderate income persons and families by lending monies on mortgage or other securities to assist to build, extend, renovate or purchase land for the purpose of building a home thereon.

The Cabinet at its meeting in May 2013 approved the transfer of Government Rental Portfolio under the Ministry of Work, Transport & Infrastructure to the Samoa Housing Corporation to operate as commercial rental properties.

The Corporation's operations are directed by a 5 - member board of directors. The Board are all appointed members from the private sector.

2. Statement of Significant Accounting Policies

Set out below is a summary of significant accounting policies adopted by the corporation in the preparation of its financial statements.

a) Statement of compliance

These financial statements have been prepared in accordance with the requirements of the Public Finance Management Act 2001 which requires the adoption of International Financial Reporting Standards issued by the International Accounting Standards Board (IASB).

In accordance with section 91 of the Public Finance Management Act 2001, Samoa Housing Corporation is designated as a Public Body, therefore it must also satisfy the reporting requirements under the Public Bodies (Performance & Accountability) Act 2001.

b) Basis of preparation

The financial statements are prepared on the basis of historical costs except for land and building which have been revalued. Reporting financial statements in accordance with IFRS requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates. The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognized in the period in which the estimate is revised if the revision affects only that period and future periods.

c) Comparative information

Comparative information has been restated where necessary to achieve consistency in disclosure with current financial year amounts.

d) Functional and presentation currency

The financial statements are presented in Samoan Tala (SAT\$), which is the corporation's functional currency and all values presented in Samoan Tala have been rounded to the nearest Tala.

e) Foreign currency

Transactions in foreign currency are translated to Samoan tala at the foreign exchange rate ruling at the date of the transaction. Amounts receivable and payable denominated in foreign currencies are translated at the rates of exchange ruling at balance sheet date. Foreign exchange differences arising on translation are recognized in the statement of financial performance.

f) Bad debts and provision for doubtful loans

Specific provision

The Corporation conducts a yearly review of individual loans accounts to recognize impairment on those loans with reasonable doubt that not all the principal and interest can be recovered in accordance with terms and conditions of the loan agreement. Bad debts are written off against the provision for doubtful debts in the period in which they are identified as unrecoverable.

f) Bad debts and provision for doubtful loans (cont'd)

General provision

The Corporation also take into account the fact that a portion of receivable balances may not be recovered due to unforeseen circumstances. Therefore, it may be prudent to create a general allowance for doubtful debts in addition to the specific allowance. The general allowance is calculated on the basis of past experience concerning recoverability of debts.

g) Revenue recognition

Interest income

Interest income on loans and investments are recognized on accruals basis. Interest on impaired loans is recognized only when income is received.

Loan fees

Loan fees are recorded when they are earned. Fees on impaired loans are recognized only when income is received.

Rental income

Rental income from investment properties is recognized on a straight-line basis over the term of the relevant lease.

h) Cash and cash equivalents

Cash and cash equivalents in the statement of financial position comprise cash at bank and on hand and short term deposits with maturities less than one year.

i) Loans and other receivables

Loans and other receivables are recorded at fair value after providing for bad and doubtful debts. At the end of each reporting period, the carrying amounts of loans and other receivables are reviewed to determine whether there is any objective evidence that the amounts are not recoverable. If so, an impairment loss is recognized immediately in the statement of financial performance.

j) Fair value estimation

Fair value is determined as follows:

- Cash assets are carried at fair value;
- Receivables are carried at book value, which is the best estimate of fair value as they are settled within a short period;
- Loans are net of provisions for impairment.

k) Financial assets

The Corporation classifies its financial assets in the following categories; loans & receivables and available for sale. The classification depends on the purpose for which the financial assets were acquired. Management determines the classification of its financial assets at initial recognition.

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted on an active market.

Available-for-sale financial assets

Available-for-sale financial assets are non-derivatives that are either designated in this category or not categorized in any of the other categories.

l) Provisions

A provision is recognized in the statement of financial position when the Corporation has a present legal or constructive obligation as a result of past event, and it is probable that an outflow of economic benefits will be required to settle the obligation.

m) Accounts and other payables

Accounts payable and other payables are recognized at cost and represent liabilities for goods and services provided to the corporation before the end of the financial year that are unpaid and arise when the corporation becomes obliged to make future payments in respect of the purchase of these goods and services.

n) Property, plant and equipment

Items of property, plant and equipment are measured at cost and/or valuation less accumulated depreciation and any accumulated impairment losses. Depreciation is charged so as to allocate the values of assets less their residual values over their estimated useful lives, using the straight-line method. All direct costs attributable to acquisition of assets have been capitalized. The following rates are used for the depreciation of property, plant and equipment:-

o) Dividends

Dividends are recognized as a liability in the period in which they are due and payable pursuant to the Public Bodies (Performance & Accountability) Regulations 2002. However, pursuant to Cabinet approval FK (16) 39 dated 25 October 2016, the dividend relating to 2013 through to 2018 are now to be retained and transfer to a reserve for the repairing of rental units of the Corporation.

p) Borrowing costs

All borrowing costs are recognized in the statement of financial performance in the period in which they are incurred.

q) Employee benefits

The corporation contributes towards the Samoa National Provident Fund, a defined contribution plan in accordance with local legislation and to which it has no commitment beyond the payment of contribution. Obligations for contributions to the defined contribution plan are recognized immediately in the statement of financial performance.

Liabilities for employees' entitlements to salaries and wages, annual leave and other current employee entitlements (that are expected to be paid within twelve months) are accrued at undiscounted amounts, and calculated at amounts expected to be paid as at reporting date.

r) Taxation

The Corporation is exempt from tax under section 51 of the Housing Corporation Act 2010.

Furthermore, Schedule 7 (paragraph 25.2) requires "a company to pay dividend in accordance with the Government's dividend policy as advised by the Financial Secretary from time to time". In May 2005, the Chief Executive Officer, Ministry of Finance advised that Public Trading Bodies would be accountable for a dividend of 50% of Net profit after tax.

In October 2016, Cabinet approved the Corporation's proposal to retain all dividends from FY:2013-2014 to FY:2018-2019 as a reserve to cover all renovation costs incurred for the remaining units plus building of new rental units. Therefore, dividends for FY2013-2014 to FY2018-2019 have been transferred to Reserve as per Note 12.

24. Financial Instruments

This section outlines the Corporation's exposure to financial risks and describes the methods used by management to control and monitor these risks. The major risks are credit risk, fair values, market risk, liquidity risk and operational risk.

a) Credit risk

Credit risk refers to the risk that a customer will default on its contractual obligations resulting in financial loss to the Corporation.

The Corporation has adopted a policy of dealing with creditworthy customers except when otherwise required by government for public beneficial reasons, and obtaining sufficient collateral where appropriate, as a means of mitigating the risks of financial loss from defaults. The Corporation exposure and the credit ratings of its customers are continuously monitored and the aggregate value of transactions concluded is spread amongst approved customers. Credit risk is closely monitored by the Lending Division and Securities and Recoveries Division through regular independent reviews designed to test the quality of credit exposures and to ensure compliance with Corporation policies.

b) Fair values

All financial instruments are carried at fair values.

c) Market risk

Market risk is the risk that changes in market prices, such as interest rates, equity prices, foreign exchange rates and credit spreads (not relating to changes in the obligor's/issuer's credit standing) will affect the Corporation's income or the value of its holdings of financial instruments. The objective of market risk management is to manage and control market risk exposures within acceptable parameters, while optimizing the return on risk.

d) Liquidity risk

Ultimate responsibility for liquidity risk management rests with the board of directors.

The Corporation manages liquidity risk by maintaining adequate reserves, banking facilities and reserve borrowing facilities by continuously monitoring forecast and cash flows and matching the maturity profiles of financial assets and liabilities.

e) Operational risk

Operational risk is the risk of direct or indirect loss arising from a wide variety of causes associated with the Corporation's involvement with financial instruments, including processes, personnel, technology and infrastructure and from external factors other than credit, market and liquidity risks such as those arising from legal and regulatory requirements and generally accepted standards of corporate behavior.

f) Operational risk (cont'd)

The Corporation's objective is to manage operational risk so as to balance the avoidance of financial losses and damage to the Corporation's reputation with overall cost effectiveness and to avoid control procedures that restrict initiative and creativity.

The primary responsibility for the development and implementation of controls to address operational risk is assigned to senior management within each business unit.
